



Waiver of Liability. Please Read Carefully:

In consideration of FRIENDS OF THE SPOIL ISLANDS, INC. furnishing services, transportation, and/or equipment to enable me to participate in this activity, I agree as follows:

I fully understand and acknowledge that outdoor activities have: (A) inherent risks, dangers and hazards; (B) that my participation in such activities and/or use of any tools or equipment may result in injury or illness including, but not limited to bodily injury, disease, strains, fractures, partial and/or total paralysis, death or other ailments that could cause serious disability; (C) that these risks and dangers may be caused by the negligence of the employees, board members, general members, officers or agents of, but not limited to, FRIENDS OF THE SPOIL ISLANDS, INC.; the negligence of the participants, the negligence of others, accidents, the forces of nature or other causes. Risks and dangers may arise from foreseeable or unforeseeable causes including, but not limited to, decision making by representatives of the Friends of the Spoil Islands, Inc., including decisions that may misjudge terrain, weather, ocean or river route location, and water levels, risks of falling out of or drowning while in a boat or any water transportation and such other risks, hazards and dangers that are integral to activities that take place in a wilderness, outdoor or recreational environment; and (D) by my participation in these activities and for use of any equipment and tools, I hereby assume all risks and dangers and all responsibility for any losses and/or damages, whether caused in whole or in part by the negligence or other conduct of the agents, officers, or employees of FRIENDS OF THE SPOIL ISLANDS, INC. , or by any other person.

I, on behalf of myself, my personal representatives and my heirs hereby voluntarily agree to release, waive, discharge, hold harmless, defend and indemnify FRIENDS OF THE SPOIL ISLANDS, INC. and their agents, officers and employees from any and all claims, actions or losses for bodily injury, illnesses, disease, property damage, wrongful death, or otherwise which may arise out of my use of equipment and tools or participation in activities with the Friends of the Spoil Islands, Inc. I specifically understand that I am releasing, discharging and waiving any claims or actions that I may have presently or in the future for the negligent acts or other conduct by the owners, agents, officers or employees of FRIENDS OF THE SPOIL ISLANDS, INC.

I HAVE READ THE ABOVE WAIVER AND RELEASE AND BY SIGNING IT AGREE. IT IS MY INTENTION TO EXEMPT AND RELIEVE FRIENDS OF THE SPOIL ISLANDS, INC. FROM LIABILITY FOR PERSONAL INJURY, PROPERTY DAMAGE OR WRONGFUL DEATH CAUSED BY NEGLIGENCE OR ANY OTHER CAUSE.
